Family Support Services Served 72 families 60% of enrolled families attended 38 parenting/life skill classes offered weekly Families also met individually with teachers and family support staff The parent education program covers topics such as life skills, health, nutrition, financial literacy, early child development and parenting 60 4% of our families moved out of homelessness and into housing Housing partner agencies have experienced cuts in funding toward providing vouchers for our clients, thus making fewer living units available

Children's Services Cuidando Los Ninos provides daily high-quality, nationally-accredited childcare services to children between the ages of 6 weeks and 5 years whose families are experiencing homelessness A total of 110 children received services during the year 88% of children received assessments as well as individualized curriculum based on the developmental assessment Developmental assessments cover all domains of the child's development, such as gross and fine motor skills, language/communication, personal/social and problem solving Additional screenings for vision, hearing, dental, health and nutrition were made possible for all the children through the Albuquerque Healthcare for the Homeless

Advocacy Services The staff at Cuidando Los Ninos presented a workshop at the 5th Annual Children without Homes National Conference Cuidando Los Ninos presented at two training teleconferences with the Head Start Regional Office and the organization's staff contributed articles to the Head Start E-Newsletter In collaboration with the National Center for Homeless Families, Cuidando Los Ninos coordinated the New Mexico Summit to End Child Homelessness and founded the New Mexico Campaign to End Child Homelessness Also in collaboration with the National Center for Homeless Families and the Everyday Democracy Project, Cuidando Los Ninos began facilitating a series of community dialogues on ending child homelessness As part of the New Mexico Campaign to End Child Homelessness Cuidando Los Ninos was asked by the New Mexico House of Representatives to prepare a report on the status of child homelessness and recommendations for ending child homelessness The U S State Department in Washington, D C requested that Cuidando Los Ninos travel to Paraguay, South America, to discuss the issues of child homelessness and the work of the organization with government officials, non-governmental organizations, community leaders, universities and others Cuidando Los Ninos was featured in the documentary "Looking in - Kids Who are Homeless", by Emmy-award winning director, Chris Schueler New Mexico Governor Bill Richardson recognized Cuidando Los Ninos as an Early Childhood Education Center of Excellence
