During FY 2010, GPEC influenced the outcome of \$89.3 million in incremental payroll comprising 2,400 new jobs of which 527 were high-paying at an average salary of \$55,000. We had 8 technology assists with a total of 209 prospects, 34 of which were international. We achieved a total editorial reach of 479 million with an estimated value of \$15 million.
