Emergency Shelter - Street outreach, drop-in day centers and overnight shelters, and immediate relief for families and individuals who are homeless. Mail and message service, eviction prevention, case management, food and clothing are available, as well as a place to escape the heat and cold and find rest and support.

4b (Code) (Expenses \$ 1,223,920. including grants of \$) (Revenue \$ 96,820.)

Work Force Development - Primavera's employment services assist homeless and near homeless adults learning new skills, entering or re-entering the workforce and succeeding in the job market. Special emphasis is placed on job placement with ex-prisoners. A continuum of services including job counseling, case management, job search classes, and job placement assist over 900 individuals annually.

4c (Code) (Expenses \$ 1,019,425. including grants of \$) (Revenue \$ 369,502.)

Transitional Housing - 184 apartment units for families, couples and individuals are located in numerous sites throughout the city and county. Varying levels of case management are available to support those who are rebuilding their lives while recovering from homelessness, illness and/or upgrading their employment.
