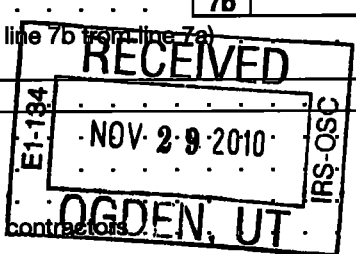

Line 20 Explanation:

After the 2008 Form 990 was mailed to the IRS, a reconciling adjustment was posted to clean up some outstanding accounts receivable balances and to reconcile the organization's bank statements. These adjustments were pending from several years prior. Rather than restating all of the prior year financial statements, these adjustments were posted to the current year (FY 2009-2010) and affected the unrestricted net assets balance in the amount of \$3,634.04. Again, rather than revise the Form 990 for Year 2008, this amount was posted to the current year fund balance account and is now reflected on the organization's balance sheet in the unrestricted net assets balance.
