SAAF's Prevention Department creates healthier communities through innovative education, training, and outreach services to reduce the transmission of HIV, Hepatitis, and Sexually Transmitted Infections by using safe and supportive approaches Prevention Services continues to target populations at increased risk of HIV infection or transmission including youth, men who have sex with men (MSM), lesbian, gay, bisexual and transgender youth, people living with HIV/AIDS, women, jail/prison re-entry men, and communities of color Prevention programs conducted 522 outreach and educational events making over 10,000 contacts, 160 participants received individual level interventions, and 22 group level interventions were conducted reaching 190 individuals HIV Counseling and Testing is now provided by both SAAF staff and the Pima County Health Department with expanded evening hours two nights a week Last year approximately 593 people were tested at SAAF and 144 at mobile-testing events

The Community Education and Resources program offers both volunteer support to all areas of SAAF in addition to providing vital outreach to the community Since its earliest beginnings, SAAF has relied on volunteers to provide much-needed client services as well as prevention outreach This still holds true today Volunteers are given training, continuing education, and staff support to acquire the skills needed to take on these important roles throughout the agency Community Education and Resources (CR) provides monthly orientations to new volunteers, as well as quarterly advanced trainings Volunteers made a record-breaking impact in 2008-2009 helping to support a healthier community through advocacy, outreach, and support Last year more than 2,000 volunteers provided 20,226 hours! The total support from volunteers last year equates to approximately \$409,576 50 according to the IndependentSector org and the Bureau of Labor Stats
