	In accordance with our mission statement Salt Lake Valley Habitat for Humanity seeks to build decent affordable homes for working families in need through partnership with individual volunteers, faith based groups and corporate sponsors Our long term goal is to make affordable housing a reality for those who do not qualify for conventional loans Since 1986, the Salt Lake Valley Habitat for Humanity has built 77 homes and housed 191 individuals Salt Lake Valley Habitat for Humanity has an additional three single family homes under construction in Magna, Utah and has started three more in South Salt Lake City, Utah as of fiscal year ending June 30, 2010 The populations we serve are low income families making just 30 to 60 percent of the area median income A family of four earns between \$19,600 00 and \$39,180 00 per year based on the 2009 HUD guidelines During the fiscal year ended June 30, 2010, Salt Lake Valley Habitat for Humanity assisted three families through new home construction Also during the fiscal year ended June 30, 2010, four additional families were prepared for home ownership through a required ten part education program and are working to complete their required 200 hours of sweat equity Salt Lake Valley Habitat for Humanity accommodated over 1,065 volunteers last fiscal year ended June 30, 2010, totaling 6,700 hours Our building sites have proven to be the perfect arena for individuals, faith based groups and corporate organizations to promote a sense of community working side by side with partner families
