REVISED BYLAWS
OF
S.A.F.E. HOUSE, INC (STOP ABUSE IN THE FAMILY ENVIRONMENT)

a Nevada nonprofit corporation

ARTICLE I
NAME, PURPOSE AND POWERS

1.1 Name. The name of this nonprofit corporation is S A.F.E. House, Inc. (Stop Abuse in the Family Environment) (the “Corporation”).

1.2 Purpose. The Corporation was formed under Chapter 82 of the Nevada Revised Statutes (“NRS”) as a nonprofit corporation for charitable purposes and not for pecuniary gain. The purpose of the Corporation is to provide temporary shelter and support to those individuals and families who are victims of domestic violence and who are seeking to break away from such abusive relationships or living situations, and the Corporation is authorized, to engage in all lawful activities incident thereto.

1.3 Powers. The Corporation shall have such powers as are now or may hereafter be granted by Chapter 82 of the NRS, as amended from time to time, and, to the extent that there is no conflict with Chapter 82, Chapter 78 of the NRS. In the event of any conflict, the provisions of Chapter 82 shall apply.

ARTICLE II
MEMBERS

The Corporation shall have no members.

ARTICLE III
BOARD OF DIRECTORS

3.1 Number, Selection The Board of Directors of the Corporation (“Board of Directors”) shall consist of at least one (1) and not more than 15 directors, all of whom must be at least 18 years of age. The number of directors may be increased or decreased by the affirmative vote of a majority of the Board of Directors, and directors shall be appointed upon the affirmative vote of a majority. No reduction in the number of directors shall have the effect of removing any director prior to the expiration of his or her term. Each director shall continue until his or her successor is elected or until his or her resignation or removal pursuant to the terms hereof.

3.2 Resignation and Removal. Any director may resign from the Board of Directors at any time by giving written notice to the Board of Directors and unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective. To the extent consistent with and permitted by Chapter 82 of the NRS, directors may be removed from office at any time upon the affirmative vote of not less than a majority of the Board of Directors.

3.3 Vacancies. All vacancies in the Board of Directors, including those caused by an increase in the number of directors, may be filled by a majority of the remaining directors, though less than a quorum.

3.4 Executive Director. The Corporation shall retain an Executive Director who shall be the chief staff executive of the Corporation. As such, the Executive Director is responsible for implementing the goals of the Corporation, empowered to hire, supervise and discharge staff in accordance with the policies approved by the Corporation and shall attend meetings of the Board of Directors. The Executive Director shall receive compensation and other remuneration for services.

3.4(a) Powers. Without prejudice to the general powers conferred by law, the articles of incorporation or these Bylaws, the Board of Directors shall have the custody, control and management of all of the property, real and personal, tangible and intangible, belonging to the Corporation and the revenues therefrom. The Board of Directors shall have full control over the affairs of the Corporation and may exercise all powers of the Corporation and do all lawful acts and things that are not by law, the Articles of Incorporation or these Bylaws, prohibited. The Board of Directors may delegate any of its authority to manage, control or conduct the business of the Corporation to any standing or special committee, or to any officer or agent of the Corporation with such powers, including the power to subdelegate, and upon such terms as may be deemed fit.

3.5 Meetings of the Board of Directors. The Board of Directors shall hold bi-monthly meetings the 3rd Monday of the odd numbered months to transact such business as may be necessary or appropriate. The Board may agree orally, by e-mail or provided by resolution the place, precise date and time for holding such meetings. Failure to hold bi-monthly meetings shall not work a forfeiture or dissolution of the Corporation.

3.6 Special Meetings. Special meetings of the Board of Directors shall be called by the Secretary on the written request of the President or any two directors. Such request shall state the purpose of the proposed meeting, and the business transacted at such special meeting shall be confined to the purpose stated in such request.

3.7 Quorum; Voting and Manner of Acting. The presence in person or by proxy of a majority of the Board of Directors shall constitute a quorum for the transaction of business at any meeting, except if less than a quorum is present, a majority of those present may adjourn the meeting from time to time without further notice. Each director present at a meeting of the Board of Directors shall be entitled to one vote. The act of a majority of the directors present at a meeting at which a quorum is present shall be the act of the Board of Directors unless a greater proportion of votes is required by law, the articles of incorporation or these bylaws to take such action, then such proportion of votes shall be required.

3.8 Telephonic Meetings. Members of the Board of Directors, or any committee thereof, of may participate in a meeting by means of a telephone conference or similar method of communication whereby all persons participating in such meeting can hear each other. Participation in a meeting pursuant to this Section 3.8 constitutes presence in person at the meeting.

3.9 Action Without a Meeting. Any action by the Board of Directors, or any committee thereof, required or permitted to be taken at any meeting of the Board of Directors may be taken without a meeting if, before or after the action, a written consent to the action is signed by a majority of the Board of Directors, or the members of the committee. If the vote of a different proportion of directors, or committee members, is required by law, the articles of incorporation or these bylaws to take such action, then such proportion of directors, or committee members, must sign the written consent. The written consent must be filed with the minutes of the proceedings of the Board of Directors, or of the committee, as applicable.

ARTICLE IV NOTICE AND WAIVER OF NOTICE

4.1 Notice. Notice of meetings of the Board of Directors shall be given by the Secretary of the Corporation at the direction of the President or any two directors. All notices shall be in writing and shall state the purpose or purposes for which the meeting is called, and the date, time and place of the meeting. Notice of such meeting shall be delivered, either personally, by mail, electronic mail, postage prepaid, or by facsimile transmission to each director entitled to vote at such meeting, not less than two days before the date of such meeting at the address or facsimile number as it appears on the records of the Corporation. If mailed, such notice shall be deemed given when deposited in the United States mail. If faxed or electronically sent, such notice shall be deemed given upon the sender's confirmation of such transmission, provided that the facsimile transmission followed by a mailing of the notice.

4.2 Waiver of Notice. Whenever any notice is required to be given under the provisions of these Bylaws, a waiver thereof in writing signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be deemed equivalent to the giving of such notice.

ARTICLE V COMMITTEES

The Board of Directors may by resolution designate one or more committees that shall have and exercise the powers of the Board of Directors. Committees shall be comprised of at least one director and any other natural persons who are not directors as determined by the Board of Directors. Notwithstanding anything contained herein to the contrary, no such committee shall have the authority of the Board of Directors in reference to (i) amending, altering or repealing the articles of incorporation or these bylaws, (ii) electing, appointing or removing any member of any such committee or any director or officer of the Corporation, (iii) adopting a plan of merger or plan of consolidation with another business organization, (iv) authorizing the sale, lease or exchange of all or substantially all of the Corporation's assets, (v) authorizing the voluntary dissolution of the Corporation or revoking proceedings therefor, (vi) adopting a plan of distribution of the Corporation's assets or (vii) amending, altering or repealing any resolution of the Board of Directors unless such resolution by its terms provides that it may be amended, altered or repealed by such committee. The designation and appointment of any such committee and the delegation thereto of authority shall not operate to relieve the Board of Directors, or any individual director, of any

responsibility imposed upon it, him or her by law. Any director may attend any meeting of any committee even if such director is not a member of such committee.

ARTICLE VI OFFICERS

6.1 Officers. The officers of the Corporation shall consist of a President, Vice President, Secretary and Treasurer, and any other officers to hold such office as may be elected and designated from time to time by the Board of Directors.

6.2 Appointment, Term and Qualifications. The officers of the Corporation shall be voted on by a majority of the Board of Directors in November of the even year. Each officer shall hold his or her office for a two year period. No officer may serve in the same office more than two consecutive terms

6.3 Resignation or Removal. Any officer may resign from his or her position with the Corporation at any time by giving written notice to the Board of Directors of the Corporation at the principal address of the Corporation and unless specified therein, the acceptance of such resignation shall not be necessary to make it effective. Any officer may be removed from his or her official position with the Corporation by the Board of Directors at any time, with or without cause.

6.4 Vacancies. Any vacancies occurring in any office shall be filled by the Board of Directors without undue delay, at any annual or special meeting of the Board of Directors.

6.5 Duties. The officers of the Corporation shall have the authority and shall perform the duties usually associated with their respective offices and such other duties as shall be assigned to them from time to time by the Board of Directors, including, without limitation, the following:

(a) President. The President shall be the chief executive officer of the Corporation, and shall have general supervision over the business of the Corporation and over its several officers subject, however, to the ultimate control of the Board of Directors. In general, the President shall perform all duties incident to the duties of the President and such other duties as may be from time to time prescribed by the Board of Directors. Notwithstanding the generality of the foregoing, the President may sign or countersign all checks, drafts and orders for payment of money consistent with, and as contemplated by, the provisions of Section 7.3 of these Bylaws.

(b) The Vice President shall, in the absence of the President, perform the duties of the President.

(c) Secretary; Assistant Secretary. The Secretary shall, in general, perform all duties incident to the office of Secretary and such other duties or functions as may be from time to time prescribed by the Board of Directors. Notwithstanding the generality of the foregoing, the Secretary shall keep a record of all of the proceedings of the Board of Directors and of such committees as the Board of Directors may prescribe, shall keep and maintain such other records as are from time to time required by the Board of Directors and shall attend to the giving and serving of all notices of the Corporation. The Secretary shall keep a register of the names and addresses of all

directors. The Secretary may sign or countersign all checks, drafts and orders for payment of money consistent with, and as contemplated by, the provisions of Section 7.3 of these Bylaws. An Assistant Secretary, if any, appointed by the Board of Directors shall perform the duties of the Secretary whenever the Secretary is absent or unable to act.

(d) Treasurer; Assistant Treasurer. The Treasurer shall, in general, perform all duties incident to the office of Treasurer and such other duties and functions as may be from time to time prescribed by the Board of Directors. Notwithstanding the generality of the foregoing, the Treasurer shall have the care and custody of all funds and securities of the Corporation and deposit the same in the name of the Corporation in such bank or trust company as the Board of Directors may designate. The Treasurer may sign or countersign all checks, drafts and orders for payment of money consistent with, and as contemplated by, the provisions of Section 7.3 of these Bylaws. The Treasurer may sign or countersign all notes or other obligations of indebtedness of the Corporation. The Treasurer shall, in accordance with the provisions of Section 7.4, at all reasonable times make available the books and accounts of the Corporation to any director upon request at the office of the Corporation. An Assistant Treasurer, if any, appointed by the Board of Directors shall perform the duties of the Treasurer whenever the Treasurer is absent or unable to act.

6.6 Other Officers. To the extent permissible by Chapter 82 of the NRS, the Board of Directors, by resolution of the Board of Directors, may authorize other offices and empower other persons or officers appointed by the Board of Directors to perform the duties and functions.

ARTICLE VII RECORDS AND REPORTS

7.1 Maintenance of Articles of Incorporation and Bylaws. The Corporation shall keep at its registered office a copy, certified by the Nevada Secretary of State, of the articles of incorporation and a copy, certified by the Secretary of the Corporation, of these bylaws, each as amended to date.

7.2 Maintenance of Other Corporation Records. The accounting books, records and minutes of proceedings of the Board of Directors shall be kept at such place or places designated by the Board of Directors, or, in the absence of such designation, at the principal office of the Corporation. The minutes shall be kept either in written or typed form, and the accounting books and records shall be kept either in written or typed form or in any other form capable of being converted into written, typed or printed form.

7.3 Bank Accounts. All checks, drafts and other orders for the payment of money, notes or other evidences of indebtedness issued in the name of the Corporation shall be signed by at least two authorized officers, shall may be the President, Secretary or Treasurer of the Corporation, or such other officers or agents authorized by the Board of Directors.

7 4 Inspection by Directors. Every director or person authorized by a director, upon at least five days written notice, shall have the right, during all reasonable hours, to inspect in person or by agent the articles of incorporation, these bylaws, each as amended to date, the books of account,

and all financial records and documents of every kind of the Corporation, and the physical properties of the Corporation and to make extracts therefrom. All costs for making extracts of records must be borne by the person exercising his or her rights hereunder. The rights authorized hereunder may be denied to a director upon his or her refusal to furnish the Corporation with an affidavit that such inspection, extracts or audit is not desired for any purpose not related to his or her interest in the Corporation.

ARTICLE VIII MISCELLANEOUS

8.1 Fiscal Year. The fiscal year of the Corporation shall commence each year on July 1 and end each year on June 30.

8.2 Amendment These Bylaws may be amended, altered or repealed by the affirmative vote of a majority of Board of Directors at any meeting thereof.


8.3 Indemnification. The Corporation shall indemnify every person who is or was a director, officer, employee or agent of the Corporation, or who is or was serving at the request of the Corporation as a director, trustee, officer, employee or agent of another corporation, partnership, joint venture trust or other enterprise (a "Covered Person"), against expenses, including, reasonable attorneys' fees, judgments, fines and amounts paid in settlement, actually and reasonably incurred by him or her in connection with any threatened, pending or completed action, suit or proceeding to which he or she is or was a party or is threatened to be made a party, to the fullest extent permitted under Nevada law. The Corporation may purchase and maintain insurance or make other financial arrangements on behalf of any Covered Person for any liability asserted against him or her and liability and expenses incurred by him or her in such capacity, to the fullest extent permitted by Nevada law.

8.4 Gifts. The Board of Directors may accept on behalf of the Corporation any contribution, gift, bequest or devise for the general purposes or for any specific purpose of the Corporation. The Board of Directors may vary the use to which a specific contribution, gift, bequest or devise can be put in the event the use for which the contribution, gift, bequest or devise is to be used becomes impossible, unnecessary, impractical or contrary to the best interests of the Corporation.

8.5 Parliamentary Authority. The rules contained in the current edition of *Robert's Rules of Order Newly Revised* shall govern the Corporation in all cases to which they are applicable and in which they are not inconsistent with these Bylaws and any special rules or order that the Corporation may adopt.
