




Question: What is the organization's primary exempt purpose?

Answer: Rotary is a world wide service organization established to provide local community service, promote high ethical standards in all vocations, and to promote world understanding and peace. A district is a geographically organized group of individual Rotary clubs. The purpose of the district is to assist and support clubs in achieving the goals enumerated above.
