Pre-school Through 5th Grade Education:

In the 2009-2010 school year, University Child Development School (UCDS) enrolled 309 students: 107 in our Early Elementary program for children age three through Kindergarten; and 202 in our Elementary program, which includes grades one through five. UCDS is committed to small classes with an average teacher to student ratio of 1:8. UCDS currently employs 24 classroom teachers, 10 resident teachers, and Spanish, physical education, art, music, science, technology and library specialists. The UCDS faculty has been nationally recognized for its excellence in educating children. UCDS' childcare program serves an average of 34 children per month. \$317,000 was spent on this program.

Teacher Education Center:

The UCDS Teacher Education Center (TEC) creates and cultivates professional development opportunities, innovative programs and educational partnerships. The TEC is committed to promoting teacher excellence and enhancing education at UCDS and in the broader community.
