Medical Case Management - Lifelong’s case managers are the center of care for people living with HIV/AIDS Case manager’s main role is to connect people to medical care, assist them with treatment adherence and to provide support services in order to achieve optimal health During the 2009-2010 fiscal year, Lifelong’s Case Management program provided 1,369 clients with referral/linkages support to access fifteen different categories of medical need, connected 236 clients to prescription drug services through the Early Intervention Program, connected 352 clients to necessary dentistry services and an additional 90 clients to primary care providers
