	The Agros model is a uniquely holistic approach to alleviating rural poverty. By providing long-term land loans to the poor along with integrated services such as community organization, training, and long-term credit, rural villages are empowered to become self-sustaining and escape the devastating effects of extreme poverty. Program initiatives undertaken in FY10 included establishment of 3 new Agros villages in Guatemala, Nicaragua, and Mexico, continued expansion to a new region in Mexico to serve indigenous Guatemalan and Mexican families, further development of an expansion strategy involving larger communities and impacting more families, development of a special irrigation project in Nicaragua, successful pilot of Women's Community Bank programs in 4 countries, and graduation of 3 Agros communities.
