The West Seattle Food Bank is a not-for-profit organization committed to providing food security and community connections to our neighbors in need. The agency distributes food, baby food, and other supplies to low-income residents of the West Seattle neighborhoods. In fiscal year ending June 30, 2010, families visited the agency over 36,000 times and the agency distributed over 1,014,751 pounds of food. The agency also delivers food to homebound elderly and disabled residents in the area, distributes food through the local senior center, provides vouchers for clients to purchase fresh produce at local farm markets and distributes baby supplies in conjunction with another agency.
