CARE OF THE ELDERLY Founders Pavilion, Inc. operates a 120-bed nursing facility located in Coming, New York. Guardian Center, Inc. owns and operates a 123-bed nursing home in Brockton, Massachusetts. Guardian Hospice of MA, Inc. provides hospice services for patients and residents of Massachusetts. Lighthouse of Revere, Inc. owns and operates a 123-bed nursing facility located in Revere, Massachusetts. Naamans Creek Care, Inc. constructed, owns and operates a 90-bed skilled nursing facility located in Boothwyn, Pennsylvania. PS Atlanta, Inc. owns and operates plantation south assisted living facilities in Dunwoody and Duluth, Georgia. Pennsylvania LTC, Inc. owns and operates Linwood Nursing Home, a 102-bed nursing facility located in Lackawanna County, Pennsylvania. and Edgehill Nursing and Rehabilitation Center, a 60-bed nursing facility located in Montgomery County, Pennsylvania. Quaside, Inc. owns and operates two nursing homes located in Massachusetts having an aggregate of 253 beds. RBRC, Inc. owns and operates a senior housing community consisting of a 40-bed skilled nursing facility, 26 personal care beds, 18 assisted living apartments, and an adult day care center and a child day care center in Kuttawa, Kentucky. Rolling Meadows Care, Inc. owns and operates a 121-bed nursing home located in Franklin Township, Pennsylvania. Somerset Care, Inc. owns and operates a 150-bed skilled nursing home facility with 11 independent living units located in Berlin, Pennsylvania. The overall aggregate patient mix in facilities operated by these affiliates is characterized by a high level of indigent patients, and the cost of caring for these patients is primarily paid for through the Medicaid and Medicare programs. CARE OF MENTALLY RETARDED INDIVIDUALS Central Florida Communities, Inc. owns and operates 3 intermediate care facilities for the developmentally disabled and 17 group homes located in central Florida. The facility was formed for the purpose of acquiring and operating intermediate care facilities and group homes for the developmentally disabled. Florida Care Properties, Inc. provides training and skill-maintenance services to five mentally retarded/developmentally disabled facilities' clients through their training centers located in Florida and Mississippi. Nassau Care Center, Inc. and Affiliates operates three 24 bed intermediate care facilities for the developmentally disabled in northeast Florida and two six-bed group homes for the developmentally disabled residents in Nassau County, Florida. The facility provides room, board, supervision, and training activities for mentally retarded individuals. Maximum effort is devoted to teaching these individuals basic skills such as dressing and personal hygiene, and, where possible, vocational skills that will allow the individual to become gainfully employed in some capacity. ADMINISTRATIVE SERVICES Health Systems, Inc. was organized and operates exclusively to supervise, direct and control the management and operation of nonprofit nursing homes, hospitals, and retirement facilities in the eastern United States.
