


 Seattle Parks Foundation (SPF) completed fundraising for the new 12-acre Lake Union Park in downtown Seattle. Seattle Parks Foundation worked closely with the City of Seattle to oversee the final construction, and ensure the park's opening happened in time for a grand community celebration in September. Seattle Parks Foundation planned all aspects of the grand opening celebration on September 25, 2010 with a sunrise to sunset community celebration along with partners The Center for Wooden Boats, Museum of History & Industry, United Indians of All Tribes Foundation and Seattle Parks and Recreation. Nine years in development, Lake Union Park is finally complete and open to the public.

4b (Code:) (Expenses \$ 551,837. including grants of \$) (Revenue \$)
 SPF completed the fundraising, design, permitting and restoration of Waterway 18 on north Lake Union. The park is now reopened to the public. SPF also collaborated with the City of Seattle and many community groups in West Seattle to realize the grand opening of Junction Plaza Park. In South Seattle, we helped complete the transfer of four parcels of land near the headwaters of Taylor Creek to the Seattle Parks Department, preserving 0.5 acres of critical salmon-rearing habitat. We also worked with the Seward Park Improvement Foundation (the new Seward Park Playground also opened in 2010), Concord Elementary School for their new playground, and Friends of Jackson Park Trail. We also entered into new partnerships with Sacajawea Elementary School, Friends of Thornton Creek and McGilvra park steering committee for their park improvement projects.

 SPF continued to manage the Bench, Tree and Swing Donation programs for the City of Seattle. SPF works with Seattle Parks and Recreation and individuals to provide amenities to parks throughout Seattle. Donations of benches, trees, and ADA accessible swings improve our parks and create opportunities for people to leave lasting legacies in their favorite parks. We work with donors, identify locations within parks for their donations, and ensure successful installation of benches, trees and swings.
