The Good Shepherd Community Health Foundation uses judiciously the interest off of our endowments and donations received from direct appeal campaigns and fundraisers, such as our Scramble for Scholarships Golf tournament and special events, to fund projects in keeping with our mission In December 2009 we partnered with the Hermiston morning Kiwanis club and sponsored the Festival of Trees raising \$9,250, in this annual fund raiser In June 2010 we held our 16th annual Scramble for Scholarships golf tournament and raised \$10,463 specifically to fund people in the community seeking health care careers In June 2010 the Foundation awarded \$9,750 in scholarship funds to eleven students \$750 to a Masters in Nursing student, \$1,000 to a physical therapy student, \$1,000 to a dentistry student, \$1,000 to a Creighton University medical school student, \$1,000 to a BMCC Nursing student, three \$1,000 nursing scholarships and four 500 scholarships to pre-medicine, nursing and pharmacy students Our scholarship committee was particularly happy to be able to support with scholarships five local high school seniors seeking health careers Foundation grants are awarded twice a year, in October and April Grants totaling \$54,882 were awarded this fiscal year as follows \$37,760 in grants were made to six designated charities including Eastern Oregon University, Blue Mountain Community College, Vange John Memorial Hospice, Domestic Violence Service West End Project, Humane Society of Eastern Oregon and the Good Shepherd Community Health Foundation from the interest on a bequest from the late Mary Ellen Paul Other grants made by the Health Foundation this fiscal year include a \$5,000 grant to Umatilla Morrow Head Start to provide support to the Healthy Start program of Umatilla County Healthy Start promotes wellness for all families when their first child is born \$1,487 was given to the GSMC Auxiliary to fund the second phase of the File of Life program \$5,000 awarded to the Good Shepherd Community Wellness Coalition to assist with costs associated with hosting the 2nd annual Family Health and Fitness day on September 25, 2010 \$985 was given to help provide instruction in cardiopulmonary resuscitation (CPR), and Automated External Defibrillators (AED) use for residents of West Umatilla and Morrow counties Money will be primarily used to purchase teaching equipment (CPR mannequins adult, child and infant, and AED Training System) and loaner manuals required for each participant \$650 Oregon DHS/Child Welfare receive funds to purchase 4 digital cameras and 30 disposable cameras that will be used by Children's Protective Services workers in the Hermiston branch of DHS/Child Welfare \$620 to the Good Shepherd Education department to fund "It's a Girl Thing Body, Heart and Soul - Wellness Strategies for Caring Women" luncheon The luncheon will provide a venue for 75 participants to learn about women's health and wellness issues \$2,500 to the Hermiston Schools to help fund outdoor school activities \$590 grant to GS Stars Program to fund the Stars program in the schools \$290 to support the Festival of Trees Benefit activities In December 2009, the Foundation again sponsored the "Community Christmas Spirit Award" This award solicited nominations from the community of individuals who represent the Spirit of Christmas, the spirit of giving throughout the year Selected as the 2009 award winners were, Kathie Mallory and Ford Bonney
