Early literacy programs reach babies and young children, especially those vulnerable to low literacy, during a crucial window for early development. And they help parents and caregivers, especially those with limited resources and reading ability, who are encouraged to become the first, best, and most permanent teachers of their children. Last year, 50,000 children, parents, and caregivers benefitted from these programs. Two examples: Raising A Reader helps parents and their young children read together at home throughout the year. The New Parent Program reaches every first-time parent in the county, encouraging parents to read with newborns and engage with the library.

School-age literacy programs reach into all eight school districts and out into the community, engaging more than 110,000 children in reading practices that cement reading skills and academic success. Two examples: Books 2 U brings inspiring “booktalkers” and take-home books to nearly 25,000 students in low performing public schools. Summer Reading is proven to strengthen school success. This year, the program broke records, reaching nearly 85,000 children, including 75% of elementary school students.

Adult and family programs and technology expansion. Nearly 29,000 people benefitted from an array of family and adult programs. Those impacted by the economic crisis benefitted from expanded computer availability, instruction, and one-on-one coaching. Children and adults gained free access to arts, cultural, and instructional programs. Program development prepared for the launch of financial literacy programs for young families and seniors at-risk of fraud.
