The larger community is an extension of L-W's classrooms, providing students opportunities for thoughtful, effective problem solving and stewardship. L-W shares its innovative educational models, knowledge and resources with others who are committed to improving lives, prospects and possibilities for young people.

	Lick-Wilmerding is a non-profit, independent, coeducational, college preparatory day school serving grades 9-12 with a tradition of integrating demanding academic courses with technical and fine arts. Endowed by San Francisco entrepreneur James Lick, the California School of Mechanical Arts opened its doors in 1895. Subsequently, the "Lick School" merged with the Wilmerding School of Industrial Arts and the Lux School of Industrial Training. The School's 445 students reflect Lick's strong commitment to cultural, social and socioeconomic diversity. 52% of students are self-identified as students of color. In 2009, there were 797 applicants for 113 places in the ninth grade, 113 ninth graders enrolled from 54 middle schools. The Flexible Tuition Program awarded over \$4.1 million to 40% of the students. Our 46 full-time teachers and 9 part-time teachers, administrators, and program directors hold 52 Master's degrees and 8 Doctorates. Performing, technical, and fine arts teachers have supplemented their formal degrees with extensive work and performance experience. The maximum number of courses a student may carry per semester is seven. Freshman may carry 8 courses because of the Body/Mind Education requirement. If a student has been approved to take three Honors courses, the course limit is seven with one of the seven classes being in Performing, Visual or Technical Arts. In keeping with L-W's 115-year tradition, every student is required to complete 2 required years of technical arts courses and to participate in the educational immersion program called Jellis Block.
