qualified low-income families with subsidized pre-school
and child care services for infants and children up to 5 years old.
This year a total of 185 children were served.

Provides daily home delivered and congregate meals to Napa seniors.
Meals, socialization, daily contact and caring volunteers allow seniors to
live in their own home independently. This year, 618 seniors were
served 85,502 meals. The program also served 11,895 meals to 104
non-senior disabled individuals.

Provides rental assistance and case management for homeless individuals
and families, and households at risk of homelessness. CANV also operates
the Samaritan Family Shelter, South Napa Shelter, Hope Resource Center,
and emergency winter shelter. This year, the shelters served 547 individuals
and 45 families including 59 adults and 89 children. The Hope Resource Center
served 473 individuals. In addition, 235 families and individuals received
homeless prevention and rapid rehousing services resulting in a significant
reduction in the average length of stay at shelters.
