

Serving the educational and emotional needs of 236 students grades Kindergarten through Eighth Grade with a comprehensive and award winning curriculum and philosophy. The School year lasts over 180 days and students matriculate into the most sought after High Schools. The school is open each day from 7:30 am until at least 6 pm. Therefore, 10.5 hours per day (conservatively), over 180 days, suggests that the school provides 1890 hours of continuous service each year. If one multiplies this through the student body number (1890 X 236), Black Pine Circle is providing 446,040 hours of education each year to our students and families. By maintaining a healthy financial aid program, the school retained nearly all students from the prior year. And the school has successfully retained its nationally recognized faculty.
