COMMUNITY SUPPORT SERVICES

More than 1,400 households received case management for referrals and goal-setting, as well as the direct services we provide including rental assistance, emergency food, clothing vouchers, translation support, and other vital services. Holiday Share -- During our Holiday food and gift program we provided holiday meals to more than 700 low-income Novato families as well as children's toys and holiday gifts for parents and guardians.

THRIVING FAMILIES, EMPLOYMENT

Over 60 families received long-term, intensive case management which included referrals for financial, employment, housing, and medical services, as well as food and clothing in accordance with their family needs and goals. Significant movement to break out of the cycle of poverty was made for the majority of these families. Over 250 individuals received employment counseling services and assistance with achieving improved employment options.
