Child Care Fund Though the Child Care Fund, the Council provides sliding-scale child care subsidies to help thousands of low-income working Contra Costa families pay for child care. The fund also provides subsidies for parents of children who are at risk of abuse or neglect, so they can attend a quality early childhood education program. The Fund allows parents to choose from a wide range of child care options so they may select the program that best meets the needs of their child and family. During 2009-2010, an average of 1,737 families and 2,955 children benefitted from the Child care fund each month

Child Health and Nutrition Program The Child Health and Nutrition Program continued its nationally recognized work to engage children, their families and child care providers to eat healthy and get active to help address issues such as childhood obesity, nutrition, and physical activity. Program Specialists provide nutrition and health education through on-site training, consultations, workshops, conference presentations and the Nutrition Edition, a newsletter with information on child health, nutrition and safety as well as activities and menu suggestions. The Program also sponsors the Child Care Food Program, which helps to reimburse family child care providers for the cost of providing nutritious meals and snacks to children in their care. During 2009-2010, more than 24,000 children were positively impacted through the Council's Child Health and Nutrition Program

Early Start to Success Initiative/Child Care Resource and Referral Program The Council assists parents in making informed choices about child care, which includes infant/toddler, preschool and after-school care serving children ages 0 - 12. Through free child care referrals, Council staff members provide information about more than 1,600 licensed providers in Contra Costa County. As part of the Early Start to Success initiative, the Council assists families with 1) parent workshops and educational materials, 2) information about how to find, evaluate and pay for care, 3) the latest on child development issues, and 4) other resources, so that parents have the knowledge and tools to ensure their children's success. During 2009-2010, the Council served 23,934 families with free consultations on parenting issues and more than 4,164 parents received child care referrals to serve nearly 6,500 children. The Council also manages the Child Care Eligibility List (CCEL), the countywide subsidy wait list for families seeking financial assistance with child care costs. At the end of June 2010, 12,032 families and 17,038 children were in the CCEL database. Of those, 3,408 families and 4,196 children were actively waiting for child care.
