FVLC's legal department continues to be recognized throughout the community as the leader in providing top-quality legal services to people fleeing domestic violence. This year FVLC provided legal information, assessment, paperwork preparation assistance, advice and council and representation to 692 legal clients. FVLC helped 179 of those clients get 267 court orders. Even with reduced staffing this was a slight increase from the prior year, when we served 661 clients.

During this program year, the unit responded to more than 3,300 police reports (2,905 in Oakland and 403 in Berkeley), and provided crisis intervention and case management to 1,806 clients. FVLC's Mobile Response Team (MRT) program served 850 domestic violence survivors in Alameda County by providing 24-hour crisis counseling, safety planning, temporary hotel relocation, transportation, advocacy and other services. Finally, FVLC managed the distribution of nearly \$62,000 in expenditures to directly assist 33 clients leaving abusive relationships by providing rental assistance, hotel stays, emergency transportation, food, and assistance with bills (including utility and medical). This fund remains a lifeline for many survivors who are struggling to get back on their feet following abuse.

Form 990, Part III, Line 4b - Program Service Accomplishments

The Education & Youth Services Department reached more than 2,400 youth at 6 Oakland schools. The Relationship Abuse Prevention (RAP) youth leadership program enrolled 61 students at Street Academy and Excel (McClymonds) High Schools. The leadership program is a weekly year-long elective course held within the school day that builds students' leadership skills by engaging them in advocating around the issues of dating and domestic violence. These youth leaders in turn reached 1,495 additional

students by developing awareness campaigns in their schools through workshops, assemblies, and health fairs. In addition, 29 youth enrolled in FVLC's after school youth internship program, logging 1,827 internship hours in the department. This was also the first year of fully implementing Start Strong activities (as part of the national initiative funded by the Robert Wood Johnson Foundation). As part of this program, FVLC taught the Safe Dates curriculum to 464 students from 4 Oakland middle schools, and reached another 351 youth through poster contests. We also developed teacher and parent training modules on the issue of teen dating violence. To date, 121 teachers have been trained at 4 middle schools

Form 990, Part III, Line 4d - Other Program Services Description

FVLC's HEAL program provided 717 clinical hours of mental health services to 26 children and their primary caregivers to help heal from the trauma experienced in domestic violence. By providing intensive parent/child psychotherapy to young children who have been exposed to domestic violence, the HEAL Program helps these children overcome the trauma of that experience so that they can go on to have a healthy, normal development.
