Form 990-EZ, Part III, Line 28:      The 2009-2010 season was Earplay's 25th season of making new music in the California Bay Area. The season included the music of eight composers who are currently active in or have strong ties to Northern California. There were four world premieres commissioned expressly for the ensemble as well as West Coast premieres and repeat performances of works previously commissioned. Earplay had an attendance of approximately 940 comprised of composers, musicians, music lovers, general music students, and those with a strong interest in the contemporary arts. Each concert was preceded by an informal talk with the composers and followed by a reception for the audience, performers, and composers. In addition, Earplay presented two programs for the City College of San Francisco music department; participated in the second Chamber Music Day that presented a sampling of diverse chamber music groups free to the public; performed in the Wooden Fish Ensemble with a work that Earplay commissioned and premiered in 2003; and organized and hosted an event, An Evening with Peter Sellars.
