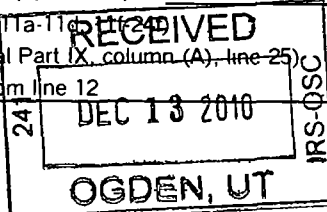

We also started a new toolkit program for young women that come to the Center but are not in a particular program, The toolkits provide opportunities for the young women to make \$50 by completing a Educational, Financial, Personal and Legal Toolkits...for example filling out an education tool kit consists of gathering: (school schedules, course guides, fasfa application, college application and transcripts from her high school). This has been a successful project; the toolkits have been a good way to bring young women in to receive services like case management, resources and referrals.

Sister's Rising Job Training and Leadership Development hires 17 system involved young women for a paid internship that incorporates healing, skills development, political education, community organizing and reintegration into the community every year. With limited education and the barrier of a criminal record, job prospects for young women are dim. Sisters Rising provides extremely low-income young women with both a livable income and an environment that is supportive and personally transformative. The young women we chose to hire have endured multiple traumas including long periods of incarceration, loss of their children while they were in the system, poverty, violence, drug addiction and the incarceration of a parent. Sisters Rising helps its participants achieve self-sufficiency and work to change the systems that impact their lives. This year with help from allies like youth justice institute, Minor Miracle, Dress for success, and STRIVE we were able to provide SR participants with 180 hours of mental health services, 72 hours of professional development including a two business suits for interviews, resume, cover letter, and 36 full case management sessions in hopes that when they leave the program they can successfully apply and obtain a permanent position.

Young Mothers United (YMU) is our youth-led advocacy project that works to ensure the rights of pregnant and parenting young women during incarceration. YMU provides support and advocacy services for young mothers' ages 16 to 24. We facilitate a 12-week peer-led parenting class for young mothers at risk of losing their babies or working on reunifying with them due to incarceration. Of the 32 who graduated from the CPS-certified class, 5 regained custody, 7 closed their case with family court, and 5 became members of YMU's coalition. YMU Project Coordinator works predominately with young mothers who are in lock-up and/or have an active CPS case. Support

services include: Department of Human Services certified, 12-week, peer led parenting class, court advocacy and accompaniment. Our parenting classes cover topics such as healthy relationships, the impact of family violence, gender roles and more. In addition to support services, YMU coordinator engages young mothers and community members in organizing to change policy on a local, state and national level. Currently YMU is working on the Incarcerated Young Mother's Bill of Rights and have membership meetings on the 4th Tuesday of every month. The YMU coordinator also facilitates a Juvenile Hall Leadership Workgroup consisting of community leaders, young mothers, system staff, and city department heads that meet quarterly regarding the successful implementation of the CYWD Incarcerated Young Mothers' Bill of Rights inside San Francisco's juvenile hall. This Bill ensures that every incarcerated pregnant young woman will have the right to prenatal vitamins, adequate nutrition and access to medical services, and to have someone with her while giving birth, and that every parenting youth will have the right to visits and phone calls with their child. We continue to advance the Young Mothers Bill of Rights (YMBOR) as policy locally and across the state. We recently screened our Public Service Announcement for the YMBOR. YMU is currently engaged in a poster campaign to get the word out about the YMBOR. As of October, they have delivered over 300 posters and My Life Chose Me handbooks- a 50-page manual and advocacy tool for young mothers fighting the Child Welfare and Criminal Justice System, to over a hundred organizations. One way the YMU coalition achieved success was expanding our base of participating young mothers. We will be sending Spark the campaign poster via mail.
