KE ALI'I PAUAHI FOUNDATION SCHOLARSHIP FUND provides scholarships to Kamehameha Schools Hawaii senior pursuing further education post graduation.

KSPTO-Hawaii Campus' **UNIFORM EXCHANGE** provides families with affordable uniforms through a recycling program of donated goods. Good used uniforms are laundered, reconditioned, and resold at prices ranging from \$1-5 per item. Proceeds from this program are used to fund Enrichment Grants. Program is run with 100% voluntary labor.
