addition to firm, consistent and appropriate guidance
in the development of social skills and one-to-one assistance
with homework for afterschoolers.

The Head Start program provides comprehensive educational services for
approximately 340 preschool children, health exams, dental care,
nutritious meals, therapy for special needs children, parent education
and social services for children who are economically or educationally disadvantaged.

The Mental Health program assists approximately 500 mentally ill adults who have gone off medication,
are in denial, are unwilling to access the traditional system of mental health care,

for persons struggling with mental illness & the attached social stigma.
