 Boys Republic's mission is to give adolescent youth with behavioral, educational, and emotional difficulties an opportunity to achieve their maximum potential for responsible, self-directed life within the community. Boys Republic provides both residential and non-residential youth services to disadvantaged, at-risk young people from throughout California. It operates six facilities, all in Southern California: a 190 acre residential campus, school, and farm in Chino Hills; three residential group homes for boys in Los Angeles, Pomona and Santa Ana; a Girls Republic group home in Monrovia; and a non-residential day treatment center and school in the city of Monrovia. Total capacity for all facilities is 235 which include 215 residential beds and 20 day treatment positions. Boys Republic provides a diverse program of educational, psychological, vocational and family reunification services.
