Mental Health Services Didi Hirsch has been providing quality mental health services in the Southern California area since 1942 Our services for youth, adults, and older adults include a) Crisis Residential Care at our two residential treatment centers where we provide a 28-day program for adults experiencing serious problems due to their mental illness, many of whom have been homeless or are at risk of homelessness The goal of the program is to provide treatment for the clients, help them become stabilized and find long-term housing b) Intensive Services and Full Service Partnerships for clients whose severe and long term mental illnesses have led to frequent hospitalizations and homelessness Agency staff work with clients in community settings and provide services as frequently as necessary c) A drop-in wellness center, offering an array of classes, groups and community activities to foster physical and mental well being d) Outpatient Treatment, including a full range of counseling and case management services and medication management e) A Child Alert program offering specialized mental health services for children who have experienced or are at risk of physical, sexual, or emotional abuse and neglect f) School-based services which are offered in more than 45 schools in Los Angeles County Our therapists work closely with teachers to address emotional and behavioral problems and help increase the child's chance of success in the classroom g) Parenting Education offered both in English and Spanish h) Assessment and mental health treatment for people on public assistance through a state program that helps reduce the barriers to employment and increase self-sufficiency i) The operation of Los Angeles County's only 24-hour suicide prevention crisis line for people of all ages at the risk of suicide In addition to the crisis line, we provide suicide education, awareness and prevention through presentations to schools, places of worship, community groups, businesses and law enforcement agencies, as well as to hospitals, counseling centers and other clinical environments

Substance Abuse ServicesWe offer substance abuse and prevention counseling for both teenagers and adults with drug and alcohol related problems In the Substance Abuse Division, the agency operates a) Community Assessment and Services Center (CASC), which assesses mental health and substance abuse needs of adults receiving General Relief and other public assistance The CASC connects clients to local treatment providers and serves as a substance abuse resource center for the Western area of Los Angeles County b) A Residential Treatment program for women providing long-term substance abuse, mental health, and domestic violence treatment in a safe, supportive, communal living environment Children up to age six can live with their mothers while they are in treatment c) Drug and Alcohol Treatment Programs for adolescents and adults provided through individual, family and group outpatient counseling at four of our nine locations
