Trinity Youth Services ("TYS"), is a not-for-profit, multi-service agency serving the needs of children requiring out-of-home placement through residential/treatment and foster family programs. TYS opened its doors in 1966 with 6 boys and has expanded to provide care for over 1,300 children on a daily basis in California, Nevada, Colorado, and Texas. Through growth and change, TYS has maintained one mission to help children heal who have been damaged by abuse, neglect, or abandonment, and return them back to their families and society. In the ensuing years, more than 40,000 children have found the inside of TYS to be a safe, healing, and caring environment, where they are valued and supported, regardless of their race, creed, or cultural background.

Trinity Youth Services was founded in 1966 as Guadalupe Homes for Boys. Our mission, then and now, is to reshape the lives of abused, socially deprived and emotionally troubled boys and girls, from newborn to 18 years old, regardless of race, religion or socioeconomic background. Through our residential treatment campuses, group homes, foster care agency, early intervention programs and other services, we extend care to children and their families.

The Residential/Treatment Program provides a wide array of treatment and residential settings including shelter and diagnostic centers for children and teens (both boys and girls), sexual abuse victim/perpetrator treatment program for latency-age and teen boys, sexual abuse treatment program for pre-teen girls, intense therapeutic treatment programs for seriously emotionally disturbed and/or behaviorally difficult late adolescent and teen boys. The program also provides short-term shelter care for teen boys and girls.

The Foster Care Program provides complete foster care services. It maintains its own staff of professional social workers skilled in recruiting, training and certifying foster parents and overseeing the placement of foster children in their homes.
