The largest program accomplishment is providing a high level, college preparatory, academic course of studies for over 400 students ensuring that almost every student attends an appropriate college, university, or post-high school service enterprise including but not exclusive to the U S Military. The academic program services children of average to exceptional abilities thereby allowing it to embrace a wide range of students in the Jewish community and thereby fulfilling our mission of being a true community-minded institution. Part of our mission is to provide high level future leadership for the American and Jewish community. This means future adults who will sit on boards of charitable organizations, schools, work in politics, and enter professions such as education, medicine, law, accounting, or business where they are able to apply their Jewish values "lens" in making decisions that involve complex ethical and moral challenges. All 400+ students graduate over time with an understanding of their obligations to leadership and ethical action.

The second largest program is the community service component of New Community Jewish High School. Every student is required to engage in multiple hours of service to the overall community in Los Angeles, and beyond in some cases.
