SHARE! Collaborative Housing We find immediate housing for disabled people, many with mental health and substance abuse issues, in an innovative public/private permanent supportive housing program. People live together in single-family houses in healthy neighborhoods, attend self-help support groups and volunteer or get a job. We find the houses, get them inspected and certified for the program, move people in and troubleshoot any problems or issues that come up, fill any vacancies. If people need to move out for any reason, we immediately offer them a place in another house, where they can try, try again. We housed 78 homeless people.

SHARE! Self-Help Clearinghouse for Los Angeles County We keep track of all the self-help support groups in Los Angeles County--more than 12,000 of them--and make referrals to people who want to attend them. We made 8,840 referrals to people desiring peer support.

SHARE! Self-Help Centers We operate two self-help support group centers: 1) SHARE! Culver City and 2) SHARE! Downtown. The centers provide meeting space for self-help support groups, volunteer opportunities, including Volunteer-to-Job--an employment program, referrals to self-help support groups, technical assistance to self-help support groups and people wanting to start groups. We provide social, emotional and tangible support for homeless people to make changes in their lives. SHARE! held 3,204 self-help support groups at SHARE! Culver City and 1,650 at SHARE! Downtown. We enrolled 64 people into our Volunteer-to-job program and 11 of those got jobs.
