Residential Programs: The Arc is the largest provider of community based residential services for persons with intellectual and developmental disabilities in Hawaii, providing homes for 122 clients. The organization operates four apartment complexes, providing homes for 48 individuals, ten domiciliary homes for 42 people, and seven intermediate care facilities/mental retardation (group homes) for 32 individuals. Each home has 4-5 residents, as well as a live-in manager and is located in a community setting. The homes provide a family atmosphere with opportunities to work, learn and play together. Living skills are practiced daily.

Day Programs: The organization's three centers provide adult day health programs, active treatment and habilitation services for over 100 persons with intellectual and developmental disabilities for about 250 days of the year. Programs and events are at the centers as well as in the community and include a variety of activities to help the individuals attain their highest potential. Activities include volunteering in the community, dance movement classes, delivering Meal on Wheels, karaoke outings, money management training, learning to use public transportation, working in a thrift shop, to name a few.
