Child Care Resource and Referral Services As Hawaii's statewide child care resource and referral agency, PATCH provides parents and caretakers with referrals to local child care providers, information about state licensing requirements, child care subsidies, and other important child care information We provide guidance by phone, in person and through our online service, so that parents can learn about the types of child care that are available in their community, learn how to choose and pay for quality child care, and how to get help with their child care related issues Parents can receive a list of child care providers that meet their specific needs via email, online or by mail PATCH, in conjunction with the National Association of Child Care Resource and Referral Agencies and the Department of Defense, is now able to offer Enhanced Referral Services and subsidy program information for Military Families and respite care services to families of active duty and activated Reserve Navy families enrolled in the Exceptional Family Member Program (EFMP)
