THE FOUNDATION'S MISSION IS TO OFFER STUDENT TEACHING OPPORTUNITIES TO COLLEGE STUDENTS MAJORING IN EDUCATION AND TO DEVELOP AFTERSCHOOL PROGRAMS. THE FOUNDATION CONTRACTS WITH ELEMENTARY, JUNIOR HIGH, AND HIGH SCHOOLS AND OTHERS TO PROVIDE TEACHING FELLOWS FOR AFTERSCHOOL EDUCATION AND TUTORING. APPROXIMATELY 600 TEACHING FELLOWS HELPED ABOUT 9,400 STUDENTS EACH MONTH AT SCHOOL SITES DURING THE CURRENT FISCAL YEAR. THE FOUNDATION OPERATES ONE MAJOR PROGRAM.
