28 Early Care and Learning (ECAL) and a group of partners including another child serving agency, Action for Children, and 5 child care centers formed the initiative Caring Communities Birth to 3. This project is working to transform early care and learning philosophy and practice for children ages six weeks to age three. During the past year, the partners had 8 meetings, held 7 teacher education trainings for 25 teachers, including a year-end presentation to the community about progress to date, and made 8-18 visits to each of the five partner child care centers for technical assistance and on-going evaluation. The second year of CC B-3 has begun with all centers having made transformational changes in their programs by grouping infants and toddlers into family style, mixed aged groups rather than same age, and with teacher training attendance increased from 25 to 30 adults who receive state certified credit for participation.
