THE ANTHONY PETRUCCELLI CHARITABLE FOUNDATION (APCF) IS ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARITABLE PURPOSES. SPECIFICALLY, THE ACTIVITIES OF APCF ARE DESIGNED AND INTENDED TO ASSIST AND ENHANCE QUALITY OF LIFE FOR UNDERPRIVILEGED FAMILIES IN THE GREATER BOSTON COMMUNITY.

CURRENTLY, APCF HAS TWO MAJOR FUNDRAISING EVENTS ANNUALLY. THE FOUNDATION OPERATES A CHARITABLE GOLF TOURNAMENT IN JUNE, HOSTING SPONSORS AND DONORS WHO CONTRIBUTE FUNDS AND SERVICES. THE FUNDS RAISED AFTER EXPENDITURES ARE PUT TOWARDS THE ANNUAL "EASTIE ELVES" EVENT.

THE EASTIE ELVES EVENT IS HELD IN DECEMBER. THIS FUNDRAISING EVENTS PRIMARY MISSION IS TO COLLECT NEW, UNWRAPPED TOYS DURING DECEMBER EACH YEAR AND DISTRIBUTE THOSE TOYS AS CHRISTMAS GIFTS TO NEEDY CHILDREN WITHIN THE EAST BOSTON COMMUNITY. THE EVENT DOES NOT CHARGE A COVER FEE OR FOR FOOD SERVED AT THE EVENT.
