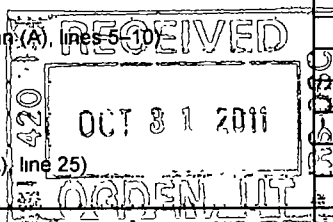

Christian Faith School served approximately 175 families and 285 students from 23 different communities throughout the Puget Sound and five different nations from around the world during the 2009/2010 school year. 100% of graduating seniors went on to attend colleges or universities of their choice. Christian Faith School is recognized by Seattle Metropolitan magazine as #1 in diversity for private schools in the Puget Sound. The School graduated 17 from the 12 grade, two of which moved on with four-year, full ride scholarships. Students participate in a wide range of community outreach activities on a regular basis including serving monthly at the Federal Way Multi-Service center helping to provide food to the needy in our community and at World Vision which services people in crisis
