Continuous support is provided to chapters through the department's commitment to hire and train Chapter Consultants who deliver presentations on risk management, officer transitions, all member retreats, new member education, diversity, and other key areas.

	The Organization supports development of the 4-Year Member Experience as a research-based, student-development focused program that provides curriculum based on life-skills for all four years of collegian's undergraduate experience. Three pieces of the program were pilot tested in 2010 in 12 chapters: Bucknell University, Syracuse University, Baker College, Purdue University, Florida State University, Sam Houston State University, Minnesota State University-Mankato, University of North Carolina-Chapel Hill, Cal Poly University-San Luis Obispo, University of California-San Diego, Southern Methodist University, Quinnipiac University.

	Leadership Academy is a fraternity-supported program that provided training and education to all chapter presidents, vice presidents of finance, and chapter advisors. The training includes sessions that focus on effective strategies in such areas as action planning, values and ethics, decision-making, conflict management, and facilitation skills. The skills needed to be a chapter officer find their foundation in basic life skills that enable our members to be more successful within their interpersonal interactions, as leaders for their campuses and communities, and for her life beyond her experiences in college.
