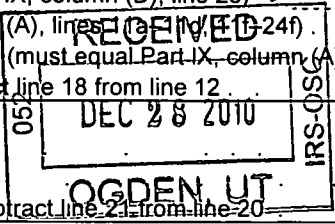

We operated after school and "Saturday school" tutorial programs in reading, mathematics, and computer and biological sciences. Approximately 2275 students attended tutorial services during the year. Over 50 tutors/mentors in fields such as education, medicine, engineering, accounting, and computer programming providing these services without pay. In addition to academic tutoring these tutors are exposed to positive role models. Additionally, 10 persons volunteered in an administrative capacity and 2 persons volunteered as prevention/college coaches.

Telehub - The telehub is a network of community technology centers established in community centers and churches. To date, twelve satellites have been developed to support our core tutorial services. The telehub program has increased access to computer technology/utilization in the inner city, as a result this program lessens the impact of the digital divide in the Kansas City, Missouri metropolitan community.

The organization provides capacity building support, training, and leadership at smaller non-profit organizations who need technical assistance because they lack the capacity internally.
