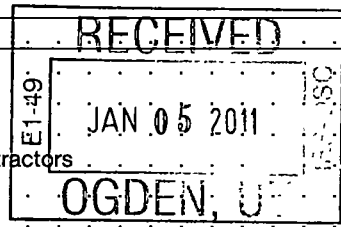

**20. Other Changes in fund balances**

There was an adjustment in the amount of (\$109.69) to the account after the books were closed which was not reflected in the prior year carry over. This was due to a transition of officers between the time the books were closed out by one officer and the tax forms prepared by the new officer.
