MATHCOUNTS BEGINS EACH YEAR BY DISTRIBUTING FREE CURRICULA AND PROMOTIONAL MATERIALS TO EACH OF THE 48,000 MIDDLE SCHOOLS IN THE UNITED STATES. THESE MATERIALS CENTER AROUND TWO DISTINCT PROGRAMS - THE MATHCOUNTS CLUB PROGRAM AND THE MATHCOUNTS COMPETITION PROGRAM. WITH THE COMPETITION PROGRAM, TEAMS OF STUDENTS PROCEED THROUGH LOCAL AND STATE PLAY-OFFS, CULMINATING IN THE MATHCOUNTS NATIONAL COMPETITION.
