AZ Academy's academic day program served 85 students for the 2009-2010 school year. With a staff and student attrition rate of 80% the school continued to grow and become more unified. Academic standards were adopted from the state of California and curriculum maps in language arts and mathematics were generated, with science and social studies maps slated for subsequent years. Students showed solid academic growth as a result of a greater focus on standards-based instruction.

Az Academy was awarded a 21st Century Community Learning Center grant in the spring of 2010 . This grant provides for an after school program for 5th and 6th grade public and private school students. The focus is to improve reading and mathematics skills, to foster positive behavior , and to develop healthy lifestyles.
