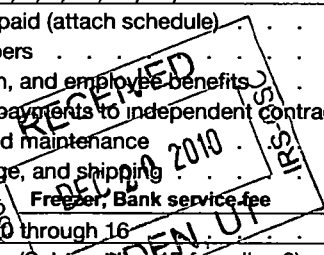

The preservation, protection, and restoration of landmarks, buildings, sites, monuments, structures or areas of historic, architectural, aesthetic or cultural significance, interest or importance in the Town of Jackson, through their protection, maintenance and development; promotion of tourism in the Town of Jackson, Louisiana; activities related to achievement of these purposes, including but not limited to funding and promotion of the funding of such activities and the administration of funds made available from public or private sources for any such purposes.
