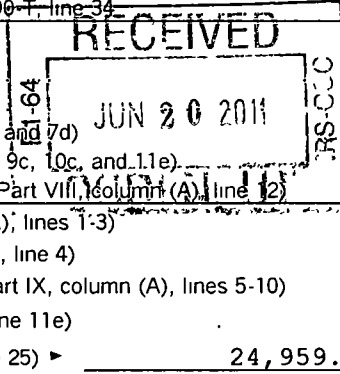

The Organization runs programs to help Jewish Education in Israel and the United States. This includes lectures by visiting scholars, working with Jewish institutions and live broadcasts of interactive Internet classes. The Organization works on programs for curriculum development in the United States and Israel. It presents lectures for the public, participates in national conferences for Jewish educators, as well as sponsoring and running internet classes. Attendance at our lectures was approximately 100 adults and we had 100 students served by our internet classes.

The Organization has funded Yad Yaakov Fund, which runs programs throughout Israel. Its programs have served over 1,800 individuals (school programs 800, adult education 150, drama programs 100, curriculum assistance 200, teaching programs, 25, religious and general outreach 200, teaching programs, 25, religious and general outreach
