The Make-A-Wish Foundation of Maine completed granting the wishes of 68 seriously ill Maine children during FY2010. The average cash cost to grant a wish was \$6,204, and the average value of in-kind gifts to each wish above and beyond the cash cost was \$2,652. An additional 36 Maine children had submitted wish requests to the Foundation as of August 31, 2011, and those wishes were in process and expected to be fulfilled within 12 months. Direct Wish Expense for the fiscal year totaled \$750,611, and overall expenses allocated to program services was \$1,007,179.
