Activities & Governance	<b>1</b>	Briefly describe the organization's mission or most significant activities The Farnum Center is a comprehensive, alcohol and substance abuse treatment facility that offers individual and group counseling in a positive atmosphere. These services include a 28-day residential program for both men and women, as well as a co-occurring disorders program for clients that also have a psychiatric diagnosis such as anxiety, depression, post-traumatic stress disorder or other mental illness. For clients who do not need residential support, the Intensive Outpatient Program takes a psycho-educational approach to clients by providing them with counseling that includes continuing care, relapse prevention and anger management. The Outpatient Program provides one hour per week of individualized counseling for clients in recovery who continue to work and live at home.


