Part X	Description of Uncertain Tax Positions Under FIN 48	The Grand Lodge accounts for the effect of any uncertain tax positions based on a "more likely than not" threshold to the recognition of the tax positions being sustained based on the technical merits of the position under scrutiny by the applicable taxing authority. If a tax position or positions are deemed to result in uncertainties of those positions, the unrecognized tax benefit is estimated based on a "cumulative probability assessment" that aggregates the estimated tax liability for all uncertain tax positions. The Grand Lodge has identified its tax status as a tax-exempt entity as a tax position, however, the Grand Lodge has determined that such tax position does not result in an uncertainty requiring recognition. The Grand Lodge is not currently under examination by any taxing jurisdictions. The Grand Lodges Federal and state tax returns are open for examination for three years following the date filed.
