Early Head Start serves pregnant mothers, infants, and toddlers up to age three, providing very young children with the care and stimulation proven to aid brain development in the earliest years. The decentralized ABCD Head Start program serves more than 2400 pre-kindergarten children including more than 2200 three-to-five year olds in 24 neighborhood based programs in Boston. It also serves more than 186 infants, toddlers, pregnant women and teen parents in Early Head start programs in Boston neighborhoods of Dorchester, East Boston and the South End. 4c - Program Service #3 ABCD's Energy Services include fuel assistance and conservation programs. ABCD Fuel Assistance helps nearly 17,000 households in Boston, Brookline and Newton pay fuel bills during the heating season. ABCD's weatherization program provides significant improvements in attic and wall insulation, weather stripping, air sealing and heating system repairs and replacements that are all designed to help low income families stretch limited resources through New England's long, cold winter months. Studies show that conservation improvements typically save 25-35 percent of winter heating bills. ABCD also provides referral and advocacy for eligible clients interested in reducing their utility arrearages. The major utilities serving ABCD's geographical area offer arrearage management payment plans and ABCD assists eligible clients have a portion of their debt forgiven while adhering to a structured payment plan. 4d - Other Program Services Other program services include health services, housing and homelessness, summer youth and other employment programs, asset development, financial literacy and elderly services. Through the Community Services Block grant, ABCD provides a variety of services to low income families through a network of neighborhood service centers that include job training, food pantries, tax preparation and drop-in services. More than 40,000 individuals received health care services, over 3,300 families received housing counseling, landlord mediation, eviction prevention, stabilization services, legal assistance and permanent housing. Over 3,800 seniors were helped to maintain independent living situations, 639 seniors participated in wellness classes, 1,139 seniors were helped with benefit enrollment services and 859 seniors received hot meals, brown bag lunches and other nutrition supports. ABCD's Youth Exploration programs focuses on the needs of at-risk and economically disadvantaged young people and provides opportunities to learn and achieve success in school and in life. Over 4,200 youth participated in summer jobs and career exploration programs. Over 900 unemployed persons obtained jobs, 599 received job counseling and another 2,059 were linked to education and training resources. ABCD's educational and work support programs helped 195 individuals gain a GED or high school diploma, 736 received ABE/ESOL services helping them join the educational mainstream, 360 received Associates Degrees or Certificates, 491 were accepted to post-secondary education or training programs and 2,421 individuals gained job readiness skills. ABCD's Financial Futures program provided 5,561 households with free tax assistance and \$8,442,234 was returned to Boston's working poor in tax refunds and credits, 676 individuals completed financial education classes and 668 individuals received credit and financial counseling services.
