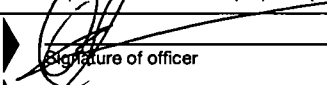

Through hands-on science explorations, meaningful visits to local communities and time to soak in the beauty and magic of the rainforest, participants will have the opportunity to learn about the many characteristics that make this region so unique as well as those that make conservation such a vital on-going challenge here. Preparatory curriculum explores the cultures of the Peruvian Amazon, the remarkable biodiversity of this region and the importance and challenges of tropical rainforest conservation.

Costa Rica Students learn field science techniques, delve into cultural studies and work hand-in-hand with Costa Rican students on a service project. Join us as we explore conservation biology in this spectacular region of the world. We'll conduct scientific field research, examine the important role that local communities play in conservation efforts, and work side by side with local students on a service project.

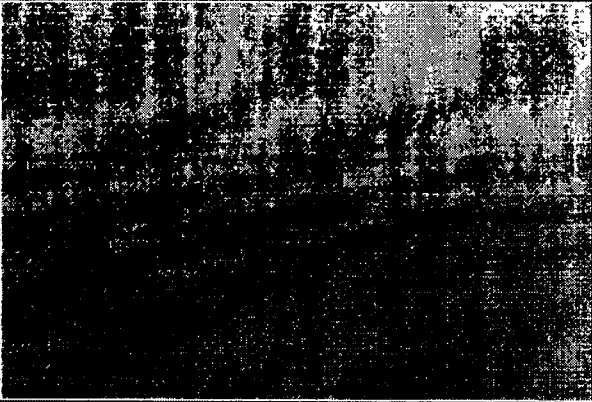
