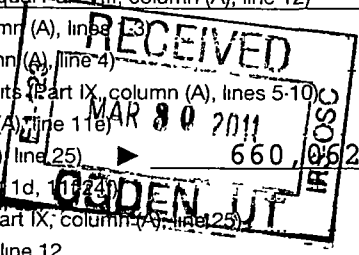

APPROXIMATELY 65% ARE AFRICAN-AMERICAN; 20% LATINO; 6% ASIAN AMERICAN; ABOUT 1% NATIVE AMERICAN; AND 8% DESCRIBE THEMSELVES AS MULTI-RACIAL OR OTHER. APPROXIMATELY ONE-THIRD LIVE AT OR BELOW THE FEDERAL PROVERTY LINE, AND VIRTUALLY ALL COME FROM WORKING CLASS FAMILIES. MORE THAN 65% OF OUR SCHOLARS COME FROM SINGLE-PARENT HOUSEHOLDS. A BETTER CHANCE HAS GROWN FROM 55 STUDENTS ENROLLED AT NINE SCHOOLS TO APPROXIMATELY 2,000 STUDENTS ENROLLED IN MORE THAN 300 SCHOOLS IN THE 2009/2010 SCHOOL YEAR.
